**Mandatory Equipment:** Cups (males), mouthpieces, hand gear, shin/instep gear, chest gear, head gear (for children)

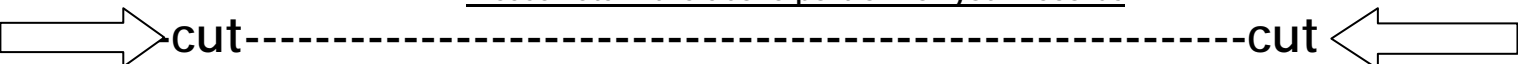

I hereby agree to the following:

1. I hereby acknowledge that I am familiar with the sport of karate and understand the rules governing American Shukokai Karate Union, Inc. Tournaments and the importance of following these rules.
2. I agree that prior to participating, I or my legal guardian have the right to inspect the mats, equipment, and facilities to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach or supervisor of such condition(s) and refuse to participate.
3. I hereby acknowledge and fully understand that I will be engaging in this tournament that may have some contact that might result in injury. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. I further agree not to intentionally inflict injury upon another person and will bear the responsibility for all my acts whether intentional or negligent and hold harmless anyone involved with this tournament and pay their damages they sustain as a result of my acts.
5. Knowing the risks and responsibility involved in this karate tournament, I assume all the risks and accept personal responsibility for the damages I might cause or receive.
6. I hereby release, waive and discharge and covenant not to sue American Shukokai Karate Union, Inc., their affiliated clubs, their respective administrators, directors, agents, coaches, and other employees or volunteers of the organization, event officials, medical personnel, other participants, their parents, guardian(s), supervisors and coaches, sponsoring agencies, sponsors, advertisers, and if applicable, owners, lessors, and lessees of premises used to conduct the event, all of whom are hereinafter referred to as "releasee," from any and all claims, demands, losses, or damages on account of injury caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise.
